3. The Transporter must have Service Tax No. and the same along with copy of PAN should be provided to the institute authorities.
4. The supplier must have at least 3 (Three) years' experience in providing Bus facilities.
5. The Bus operator, who have at least 3-5 Buses registered in their name can only participate in the tender.
6. The tender bid should be submitted in sealed envelope superscripted as tender for "Hiring Bus Services for UT. Level Selection at Diu". By paying Rs. 500/- as
