As, for example, in case of Government Servants or those in private service, the income can be verified by a reference to the employers. In the case of agriculturists by a reference to the Revenue Officer, in the case of persons paying income – tax, reference may be made to Income – tax authorities. In the case of shop – keepers, reference may be made to sales – tax figures, sales tax figures could in turn, assuming a normal profit of 10 per cent to 15% to in case of retailers and 15% to 20% in the case of wholesale dealers for grains, etc., and normally 15% to 20% for non-food items, give an idea of profit.
