(N.B.:- Mostly the income declaration will be verified by a reference to official records. As, for example, in case of Government servants or those in private service, the income can be verified by a reference to the employers. In the case of agriculturists by a reference to the Revenue Officer, in the case of persons paying income - tax, reference may be made to Income - tax authorities. In the case of shop - keepers, reference may be made to sales - tax figures, sales tax figures could in turn, assuming a normal profit of 10% to 15% to in case of retailers and 15% to 20% in the case of wholesale dealers for grains, etc., and normally 15% to 20% for non-food items, give an ideal of profit. In the case of those owning houses, annual rental value can be easily known by the reference to house tax which is fixed on the basis of e\rental value. In the case of landless laborers, small holders tenants of small areas of those who combine this, a rough idea of income can be obtained by a study of the size of land held and extent of land cultivated as owner/ tenant or both and / or a reference to land revenue records.
