Subject: Regarding proposed amendment in the Recruitment Rules for the post of Workshop Instructors in the Technical Educational Institutions (Diploma) under the U.T. Administration of Dadra & Nagar Haveli and Daman & Diu.

As per the Office Memorandum No.AB-14017/61/2008-Estt(RR) dated 13/10/2015 issued by the Department of Personnel & Training (DOP&T), New Delhi regarding the proposed amendment/revision of Recruitment Rules (RR) should be uploaded on the website of respective Ministries/Departments for 30 days for inviting comments/suggestions from the stakeholders.

Administration of Dadra & Nagar Haveli and Daman & Diu will proceed for taking further necessary action for amendment of aforesaid draft Recruitment Rules in this U.T. Administration.

NOTIFICATION

In exercise of the powers conferred under proviso to Article 309 of the Constitution delegated to him vide Government of India, Ministry of Home Affairs, New Delhi's Notification No. 7/1/65-Est (A) dated 16th February, 1965 and Department of Personnel and Training, New Delhi O. M. No. AB-14017/13/2016-Estt. (RR) dated 18th January, 2017 and in super-session of all earlier Notifications, the Administrator, Dadra and Nagar Haveli and Daman & Diu hereby amends the following rules regulating the method of recruitment to the General Central Service Group 'C' (Non-Gazetted, Non-Ministerial) post of Workshop Instructor under the Directorate of Technical Education in the Union Territory of Dadra & Nagar Haveli and Daman & Diu Administration, namely:-

1. <u>Short title and commencement:-</u>

- i) These rules may be called, the Administration of Dadra & Nagar Haveli and Daman & Diu, Workshop Instructor, Group 'C' (Non-Gazetted, Non-Ministerial) Recruitment Rules, 2021.
- ii) They shall apply to the post specified in Colum No.1 of the schedule to this rules.
- ii) These rules will come into effect from the date of publication of this notification in the Official Gazette and will relate to appointment to the posts made on or after this date.

2. Number of Posts, Classification and Level in the Pay Matrix:-

The number of the posts, their classification and the Level in the Pay Matrix attached thereto shall be as specified in Column 2 to 4 of the Schedule annexed to these rules.

Provided that the Administrator of Dadra and Nagar Haveli may vary the number of posts in column 2 of the said schedule from time to time subject to exigency of work.

3. <u>Method of recruitment, age limit, qualification etc:-</u>

The method of recruitment, age limit, qualification and other matters relating to the said posts shall be as specified in column 5 to 13 of the said Schedule.

4. <u>Disqualification :-</u>

No person (a) Who has entered into or contracted a marriage with a person having a spouse living, or (b) Who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post. Provided that the Administrator may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so dong exempt any person from the operation of these Rules.

5. <u>Power to relax:-</u>

Where the Administrator of Dadra and Nagar Haveli is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be record in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. <u>Saving:-</u>

F.

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Class and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regards.
