## ORDER

In pursuance of the General Lok Sabha Election 2014, there have been apprehensions of transportation of liquor from Daman to other states of India in large scale and to prevent any such attempt by undesirable elements, the Excise Officials of U. T. of Daman & Diu are hereby directed to maintain strict vigil in entire district of Daman and district of Diu to carry out necessary verifications as under :-

- 1. There should not be any transportation of liquor in the U. T. of Daman & Diu without valid transportation permits issued by the Excise Inspectors of Excise Department, Daman and Diu. The Excise Officials are directed to verify the quantity under transportation whether it matches with the quantity mentioned in transport permits, batch numbers, vehicle number used in transportation and name of driver and other staff.
- 2. The stock of liquor held by licensee should tally with the stock register maintained as per the provisions of excise Act and Rules and the quantity of liquor stored with them should be accounted for.
- No person not being a licensed manufacturer or dealer of liquor should be allowed to have in his possession quantity of liquor beyond the limits permissible under the Excise Act and Rules.
- 4. The officials posted at the check posts are directed to keep utmost surveillance on all vehicles passing through the check posts. Any vehicle with suspicious movements must be checked thoroughly. Similarly, the fishing vessels must also be kept under surveillance.
- 5. All the licensses under the jurisdiction of each Excise Officials be directed to maintain full account of the transaction of liquor on day to day basis and

action shall be initiated in such instances where unaccounted liquor is

found stored or transported.

All the Excise Officials of U. T. of Daman & Diu are directed to follow the above instructions/guidelines and other provisions of the Excise Act and Rules in letter and spirit. Non-compliance of these instructions will be viewed seriously
