2) A notice dated 21/01/2017 issued by the Deputy Commissioner of Excise, Daman to all license holders of Daman & Diu for strict compliance of the order of the Hon'ble Supreme Court.

## <u>ORDER</u>

The Hon'ble Supreme Court of India vide judgment / order dated 15/12/2016 directed as under:

- (i) All States and Union Territories shall forthwith cease and desist from granting licenses for the sale of liquor along national and state highways;
- (ii) The prohibition contained in (i) above shall extend to and include stretches of such highways which fall within the limits of a municipal corporation, city, town or local authority;
- (iii) The existing licenses which have already been renewed prior to the date of this order shall continue until the term of the license expires but no later than 1 April 2017;
- (iv) All signages and advertisements of the availability of liquor shall be prohibited and existing ones removed forthwith both on national and state highways;
- (v) No shop for the sale of liquor shall be (i) visible from a national or state highway; (ii) directly accessible from a national or state highway and (iii) situated within a distance of 500 meters of the outer edge of the national or state highway or of a service lane along the highway.

AND WHEREAS, in compliance with the said order/ judgment, the Excise Department issued notices dated 21/01/2017 to all the license holders of Daman & Diu for strict compliance of the order/ judgment of the Hon'ble Supreme Court of India.

AND WHEREAS, a committee was constituted by order dated 23/02/2017 for inspection and survey of all the licenses for identification of the licenses affected by the above order/ judgment of the Hon'ble Supreme Court of India.

AND WHEREAS, the committee has identified 58 (fifty eight) such licenses for sale of liquor situated within the distance of 500 meters of the outer edge of the National Highway on each side of the road which are listed in the Annexure enclosed herewith.

NOW THEREFORE, all the license holders listed in the annexure are hereby informed that in light of the order dated 15/12/2016 of Hon'ble Supreme Court of India all these licenses shall stand cancelled w.e.f. 01/04/2017.
