The courses are academically affiliated to Veer Narmad South Gujarat University, Surat and recognized by Gujarat Nursing Council, Ahmedabad and Indian Nursing Council, New Delhi.

2.2 GOVERNMENT COLLEGE OF NURSING, DAMAN

6. DETAILS ABOUT THE BASIC B. Sc. NURSING ADMISSION PROCESS:

6.1 ADMISSION REQUIREMENTS

- Only Female candidates of Indian origin are eligible.
- ❖ The minimum age of admission shall be 17 years and the maximum age limit shall be 35 years on 31st December of the year in which admission is sought.
- ❖ Candidate shall be medically fit.
- Color blind candidates are eligible provided that color corrective contact lens and spectacles are worn by such candidates.
- ❖ Married candidates are also eligible for admission.
- Students shall be admitted once in a year.
- ❖ Candidate should appear for the computer based entrance test conducted by the competent authority.

6.1.1 Minimum Educational Qualification:-

- ❖ Candidates who have passed the qualifying 12th standard examination (10+2)with Science and must have obtained a minimum of 45% marks in Physics, Chemistry and Biology taken together and passed in English individually.
- ❖ Candidates are also eligible from State, Open School recognized by State Government and National Institute of Open School (NIOS) recognized by Central Government having Science subjects and English only.
- ❖ English is a compulsory subject in10+2 for being eligible for admission to Basic B. Sc. Nursing.

Implementation of changes with regard to admission process/selection criteria will be incorporated as per Indian Nursing Council, New Delhi, Gujarat Nursing Council, Ahmedabad, Veer Narmad South Gujarat University, Surat and UT Administration of DNH & DD notifications issued from time to time.

6.1.2 Reservation Policy

- ❖ Reservation of seats for admission in Nursing Colleges for SC/ST/OBC/EWS/PH
- ❖ Admission under the reserved quota shall be subjected to reservation policy and eligibility criteria for SC/ST/OBC/EWS prescribed by the Central Govt. /State Govt./Union Territory as applicable to the College concerned.
- ❖ In respect of candidates belonging to SC/ST/OBC the marks obtained in core three subjects shall be minimum 40% instead of 45% for General and EWS category candidates.

❖ Disability reservation of 5% to be considered for disabled candidates with a disability of locomotor to the tune of 40% to 50% of the lower extremity and other eligibility criteria with regard to minimum educational qualification will be same as prescribed for General category candidates. The upper age limit shall be relaxed by 5 years for disabled candidates.

Note: Candidates with disability have to submit the disability certificate obtained from a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals / Institutions. The candidate should also appear before an Institutional Medical Board and obtain a valid Disability Certificate prior to admission.

- Candidates from EWS Quota should have recent EWS Certificate sanctioned from the Mamlatdar of DNH & DD.

- 2. The Computer based entrance test will be held at specified centres of: <u>Silvassa</u>, <u>Daman, Diu, Surat and Vapi</u>.
- 3. List of the candidates and their computer based entrance test centres will be displayed on the department websites five days before the scheduled date of

- computer based entrance test.
- 4. Admit Card for the computer based entrance test can be downloaded from the website five days before the scheduled date of computer based entrance test by using login id and password.
- 5. No assistance will be given to the candidates on the day of computer based entrance test.
- 6. Students who do not know how to / who wants to practice computer based entrance test may take up a mock test which will be available in the department's web sites. The students need to use their login id and password for writing mock test.

b) The general standards of computer based entrance test will be based on 11th and 12th that is 80% of questions related to PCBE subjects and 20% of questions related to aptitude for Nursing.

6.2.5. SELECTION CRITERIA:

- 1. The female candidate should be of Indian origin.
- 2. The minimum age for admission shall be 17 years on 31st December of the year in which admission is sought. The maximum age limit for admission shall be 35 years.
- 3. Admission of the candidate is purely based on the merit list on the basis of computer based entrance test and priority. Minimum qualifying marks for entrance test shall be 50th percentile.
- 4. The candidate must be medically fit except those who have applied under physically handicapped category and must submit a medical fitness at the time of admission.

5. The allotment of seats will be made in the following order of priority:

First Priority

Applicant's who have Domicile certificate or Applicant whose parent have Domicile Certificate or Applicant whose Guardian have Domicile Certificate (In Case Father and Mother are not alive), specifically the domicile Certificate of U.T. of DNH & DD issued by the Mamlatdar.

The applicant should have continuously studied for at least 5 years, i.e. from Class 8th to 12th in any of the recognized school of **U.T. of Dadra & Nagar Haveli, Daman and Diu.**Second Priority

If the seats remain vacant after the allotment to the first priority applicants, the application falling in the following condition will be considered in second priority:-

Applicants who have Domicile certificate or Applicant whose parent have Domicile Certificate or Applicant whose Guardian have Domicile Certificate (In Case Father and Mother are not alive), specifically the domicile Certificate of U.T. of DNH & DD issued by the Mamlatdar and the applicants have studied from any recognized educational institution.

Third priority

If the seats remain vacant even after the allotment to the first and second priority applicants, the applicants falling in the following condition will be considered in the Third priority:-

Applicant's / applicant whose parent/guardian (in the case Father and Mother is not alive) are employees (regular/deputation/transfer) of the UT Administration of **Dadra & Nagar Haveli, Daman and Diu** (Govt. servant/Central Government/state Govt./Nationalized Bank/Cooperative Bank Employees), who has continuously served in this Administration for minimum 5 Years at the time of application.

The Applicants should have continuously studied for at least 3 years i.e. from 10th to 12th class in any of the recognized School of **U.T. of Dadra & Nagar Haveli, Daman and Diu.**

Fourth Priority

If the seats remain vacant even after allotment to the First, Second and Third priority applicants, then all the other eligible applications received on merit as per computer based entrance test marks from other States and UT's will be considered in the fourth priority.

Note:

- I) In case father not alive, Domicile Certificate of Mother will be valid
- II) In case Father and Mother are not alive, Domicile Certificate of the Guardian will be valid. The Mamlatdar, of Dadra & Nagar Haveli, Daman and Diu will issue the necessary Domicile Certificate to Guardian.
- 6. The dependent certificate issued by the Mamlatdar, of Dadra & Nagar Haveli, Daman and Diu will have to be attached to the application in case of those who are claiming the guardianship of the applicant/candidate. In that case Domicile Certificate of the said Guardian will also have to be produced.
- The Certificate for SC/ST/OBC/EWS should be obtained from Mamlatdar, Dadra
 & Nagar Haveli and Daman and Diu.
- 8. The benefits of reservation for SC/ST/OBC/EWS shall be given to only those applicants/candidates whose parent have Domicile of DNH and DD.
- 9. Any attempt on the part of candidate to influence the department directly or indirectly will be treated as unfair means resulting in disqualification of candidature.
- 10. In case of any dispute, the same shall be settled within the jurisdiction of DNH and Daman.

- 2. Merit list shall be prepared on the basis Computer Based Entrance Test marks and as per priority and category mentioned above.
- 3. All the applications will be considered in the general category in the first instance. In case the applicant fails to get admission in the general category, her application will be considered in the reservation category (SC/ ST/ OBC/EWS/PH) for which she has applied.

- 4. In case of two or more candidates obtain equal marks in the Computer Based Entrance Test, their merit will be determined in order of preference as under:
 - i. Candidates obtaining higher marks in the subjects Physics, Chemistry, Biology (PCB) of 10 +2 standard board examination or any equivalent examinations shall be placed higher for merit, falling which,
 - ii. Candidates obtaining higher marks in the subject Biology of 10+2 or equivalent examinations, falling which,
 - iii. Candidates obtaining higher marks in the subject Physics of 10+2 or equivalent examinations, falling which,
 - iv. Candidates obtaining higher marks in the subject Chemistry of 10+2 or equivalent examinations, falling which,
 - (Note: The above mentioned 10+2 standards board examination in the above para (i) to (iv) states that for CBSE/ ICSE applicants, it is the marks obtained in the final year examination while for GHSE applicants, the aggregate of the marks obtained in the 3rd and 4th semesters will be considered.)
 - v. Candidate obtaining higher percentage of marks (aggregate) in standard X (SSCE), falling which,
 - vi. Candidate who are older in age.
 - (Note: Incase the applicant appears for these subjects in second attempt and clears, then the marks secured in the second attempt only will be considered.
- 5. Any attempt on the part of candidate to influence the department directly or indirectly will be treated as unfair means resulting in disqualification of candidature.
- 6. In case of any dispute, the same shall be settled within the jurisdiction of DNH and DD.
- 7. No individual intimation will be sent to the non-selected candidates.

1. The period of training is strictly full time and ordinarily continuous.

2. Joining Time:

Classes will be commencing from 1st January 2022

The date of joining the college will be intimated once counselling process is completed. The provisionally selected candidates must join their respective college on the said date. No extension in joining shall be granted. The selection of those candidates who fail to join by the stipulated date shall automatically stand cancelled and no correspondence shall be entertained. 3. Medical Examination

1. EXAMINATION REGULATIONS:

Note:

- Applied Anatomy and Applied Physiology: Question paper will consist of Section-A Applied Anatomy of 37 marks and Section-B Applied Physiology of 38 marks.
- Applied Sociology and Applied Psychology: Question paper will consist of Section-A Applied Sociology of 37 marks and Section-B Applied Psychology of 38 marks.
- Applied Microbiology and Infection Control including Safety: Question paper will consist of Section-A Applied Microbiology of 37 marks and Section-B Infection Control including Safety of 38 marks.
- 4. Applied Nutrition and Dietetics and Applied Biochemistry: Question paper will consist of Section-A Applied Nutrition and Dietetics of 50 marks and Section-B Biochemistry of 25marks.
- 5. Pharmacology, Genetics and Pathology: Question paper will consist of Section-

- A of Pharmacology with 38 marks, Section-B of Pathology with 25 marks and Genetics with 12 marks.
- 6. Nursing Research and Statistics: Nursing Research should be of 55 marks and Statistics of 20 marks.
- A candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each course/subject for appearing for examination.
- 8. A candidate must have 100% attendance in each of the practical areas before award of degree.
- Following exams shall be conducted as College exam and minimum pass is 50%
 (C Grade) and to be sent to the University for Inclusion in the marks sheet and shall be considered for calculating aggregate.
 - i. Communicative English
 - ii. Health/Nursing Informatics and Technology
 - iii. Professionalism, Professional Values and Ethics including Bioethics
 - iv. Introduction to Forensic Nursing & Indian Laws
- 10. Minimum pass marks shall be 40% (P grade/ 4 point) for English only and elective modules.
- 11. Minimum pass marks shall be 50% in each of the Theory and practical papers separately except in English.
- 12. The student has to pass in all **mandatory modules** placed within courses and the pass mark for each module is 50% (C Grade). The allotted percentage of marks will be included in the internal assessment of College/University Examination.
- 13. A candidate has to pass in theory and practical exam separately in each of the paper.
- 14. If a candidate fails in either theory or practical, he/she has to re-appear for both the papers (Theory and Practical).
- 15. If the student has failed in only one subject and has passed in all the other subject of a particular semester and Grace marks of up to 5 marks to theory marks can be added for one course/subject only, provided that by such an addition the student passes the semester examination.
- 16. The candidate shall appear for exams in each semester:
 - i. The candidate shall have cleared all the previous examinations before appearing for fifth semester examination. However, the candidates shall be

- permitted to attend the consecutive semesters.
- ii. The candidate shall have cleared all the previous examination before appearing for seventh semester examination. However, the candidates shall be permitted to attend the consecutive semesters.
- iii. The candidate shall have cleared all the previous examination before appearing for final year examination.
- iv. The maximum period to complete the course successfully should not exceed 8years.
- 17. The candidate has to pass separately in internal and external examination (shall be reflected in the marks sheet). No institution shall submit average internal marks of the students not more than 75% (i.e. if 40 students are admitted in a course the average score of the 40 students shall not exceed75% of total internal marks).
- 18. At least 50% of the Non-nursing subjects like Applied Anatomy & Physiology, Applied Biochemistry, Applied Psychology & Sociology, Applied Microbiology, Pharmacology, Genetics, Nutrition & Dietetics, Communicative English and Health/Nursing Informatics & Technology should be taught by the Nursing teachers. Teachers who are involved in teaching non-nursing subjects can be the examiners for the program.
- 19. Maximum number of candidates for practical examination should not exceed 20 per day. Particular year and of same institution batch shall be examined by the same set of examiners.
- 20. All practical examinations must be held in the respective clinical area.
- 21. One internal and one external examiner should jointly conduct practical examination for each students
- 22. An examiner for theory and practical/OSCE examination should be an Assistant Professor or above in a College of Nursing with M.Sc. (Nursing) in concerned subject and minimum 3 years of teaching experience. To be an examiner for Nursing Foundations course, the faculty having M.Sc. (Nursing) with any specialty shall be considered.

8. FACILITIES OF THE COLLEGE

Colleges have their own well planned building and are associated with civil hospital located within the campus as a parent hospital, to enable the nursing students to acquire knowledge through clinical experience. Students are also posted in rural health centers for their community experience.

8.1 Ragging free environment:

As per the University Grants Commission Act, 1956, Ragging is strictly prohibited inside the campus and Anti Ragging Affidavit (Annexure -2) will be taken once admission is confirmed.

8.2 Library

Well-furnished spacious library with adequate number of books and journals with all the modern facilities including E- learning is available for the students within the campus.

Well-furnished hostel and mess facilities are provided for the students within the campus.

Students are to abide by hostel rules and regulations otherwise they shall be expelled from the hostel and debarred for re-entry in the hostel.

Application form for admission to hostel and Rules & Regulations governing stay in hostel can be obtained from the college office.

A distinct dress code for the students of all courses, with a sole objective to instill a sense of uniformity and also to inculcate the culture and values in them.

Extend free services of Medicare and Dental Care to the students. Provision of highly specialized facilities like C.T scan, MRI scan and Echocardiography are also available round the clock inside the hospital and are provided to the students in an extremely subsidized rates.

8.7 Sports and fitness facilities

- ➤ For all round development of the students liberal arrangements have been made for indoor and outdoor games and sports facilities to provide them with ample competitive and recreational opportunities.
- To facilitate sports activities, play ground is available for volley ball, badminton and cricket etc. Apart from these, multipurpose ultra-modern gymnasiums, yoga and fitness center is also arranged with the support from the physical trainer.

- ➤ Institutions provide them ample opportunities for recreations and extracurricular activities after the study hour.
- > Students are permitted for participating in various sports events at the institutional, inter collegiate or inter university, state or national level.

8.8 Counseling and Guidance

- ➤ Counseling for a better adjustment to life is provided by the expert counselors and teachers which helps the students to solve the problems arising out of academic and non- academic challenges. Career counseling services are arranged to assist students on a vast spectrum of subjects relating to career planning, employment prospects, career choices and job search.
- ➤ Counseling is also provided to help the students in maintaining a healthy mind and cordial relationship among themselves. Services of trained and experienced clinical psychologists are made available to any student who needs guidance at any time.

8.9 Security services

The college engages 24x7 high–end security service for the safety and security of students.

8.10 Stipend/ Scholarships

Monthly stipend and scholarships during the course for eligible Basic B. Sc. Nursing candidates are provided by the administration (As per the protocol).

8.11 Banking Services

In order to facilitate quick and easy transactions, especially for outstation students, stipend services are made available through nationalized bank located nearby the college.

8.12 Memberships

The students join as members of the Student Nurses Association and after completion of course, can join as a Life Member of Trained Nurses Association, and register their names in the Gujarat Nursing Council and various other organizations in the nursing field.

8.13 Placements

Campus interview will be conducted in final year of the course by reputed institute for student's job placements.

9.1 RULES AND REGULATIONS TO BE OBSERVED IN THE COLLEGE

College of Nursing prepares its graduates to become exemplary citizens by adhering to code of ethics and professional conduct at all times in fulfilling personal and professional obligations.

- 1. Every student admitted to the Basic B.Sc. Nursing course shall have to follow rules and regulations.
- 2. Students are accountable for their behavior to the authorities in institute, clinical posting and co-curricular activities.
- 3. All the disciplinary decisions taken by the management will be final.
- 4. Students must assemble in the college campus for the prayer sharp at 7.45 am every day.
- 5. Students are required to be regular and punctual for the class. Students are expected to be in the class at least 5 minutes before the commencement of the period.
- 6. Students should maintain perfect order and strict silence inside the lecture hall.
- 7. Movement outside the class room in between lectures should be minimum and for valid reasons only.
- 8. Loitering around the corridors during classes and attending other classes are not allowed.
- 9. Students should maintain silence in the class, library, reading room and in the corridors. Students should make every effort to take care of the college and hospital property and help in maintaining the same. They should not write on the white board, smart board, scribble on tables, chairs, walls etc.
- 10. Students are not allowed to come directly to the Principal office without permission of the class coordinator, until there is any emergency.
- 11. If the students have any problem, they should inform the class representative and the class representative will intimate it to the class coordinators and if not resolved by class coordinator, coordinator will intimate to the Principal. The students should not by-pass the above mentioned channel. In case of urgent/serious issues the exception is excepted.
- 12. A student nurse is not allowed to receive gift or gratuity of any sort at any time from the patient or their relatives.
- 13. Students are required to maintain ethical and professional behavioral standards in both inside and outside the college, hospital, hostel and community premises.
- 14. Each student is responsible for the proper handling and safe custody of any apparatus or equipment that she may be using in different nursing labs, clinicals or classroom. Misuse or negligence will result in replacement of the particular item by the candidate. Any willful damage done to the property of the college or hospital will be treated as breach of discipline.

- 15. Students are not allowed to paste notices within the institutions premises without any prior written permission from the Office of the Principal.
- 16. Students are forbidden to communicate without professional reason with any person outside the authority without permission from the Office of the Principal.
- 17. Any student who damages the reputation of the college in any way is liable to be expelled. If any student discontinues the course, she shall clear all dues before leaving the college. If she fails to clear the dues, her original certificates will be retained and will be returned once the dues are cleared by the student.
- 18. Violating the rules will be dealt seriously. If necessary, the required action will be taken by the authorities, depending upon the seriousness of the violation of rules extending to dismissal from the institute.
- 19. The college provides transport facilities for students field work but whenever this is not feasible, they have to use public transport at their own expenses.
- 20. When students are posted outside DNH and DD for field experience / field work, expenses shall be borne by the students.
- 21. Rules are subject to change.

9.2 DRESS CODE:

The students are expected to attend college well-dressed on all working days

- 1. Student has to wear separate uniform for clinical and classes as approved by the institute.
- 2. Hair must be put up neatly. Jewels, ear rings, painted fingernails, threads and bracelets on hands etc. are not allowed. Students must be neat and tidy at all times.
- 3. Students are required to carry their identity cards during college hours, clinical and whenever they are going out and must produce whenever it is asked by the concerned authority.
- 4. Students are encouraged to wear simple and decent dress suitable for an academic environment during the co curricular activities.

9.3 ATTENDANCE REQUIREMENTS:

Regular and punctual attendance in all class activities likes lectures, demonstrations, and practical, clinical teaching, tests etc. is compulsory. Regular college time is 8:00 am -5:00 pm. Students should participate in all college activities like clinical meetings, conferences, guest lectures, seminars as well as sports and cultural activities etc.

- 2. A candidate must have 100% attendance in each of the practical areas before the completion of the course.
- 3. As per the VNSGU Surat, INC, New Delhi, and GNC Ahmedabad regulations, no student shall be allowed to appear in the annual examination of the concerned subject if her theory and practical attendance is less than 80% of the total sessions.
- 4. Permission for leave or absence from the classes must be taken from the class teacher and Principal.
- 5. In case of illness, permission shall have to be obtained from the Principal to remain absent from studies.
- 6. The students should not be absent / take leave without prior permission from the Class teacher and Principal. Any unauthorized absenteeism will be viewed seriously and liable for disciplinary action.
- 7. If the student is unable to return on time after vacation due to illness, it is mandatory to submit the Medical Certificate.
- 8. If a student is in need to leave the college or hospital in the middle of a day, for any emergency, she should get it sanctioned from the class teacher and principal, and a letter to that effect must be produced from the parent or guardian.

9.4 ACADEMIC STANDARDS

- 1. Students should attend all tests and show good academic progress.
- 2. Regularity in writing tests and satisfactory performance of students in tests are essential for permitting the students to appear for the university examination at the end of the academics.
- 3. Besides the curricular activities, the students are expected to participate in all extracurricular activities such as sports and cultural events.

9.5 DISCIPLINE OF THE STUDENTS

- 1. Identity Card is mandatory during College and Clinical timings.
- 2. Rules and regulation in relation to students discipline will be enforced effectively to maintain discipline and to keep up the decorum of the College.
- 3. Students should abide by the rules and regulations of the College and Hospital strictly.
- 4. Ragging or any other form of indiscipline will invite strict disciplinary action from the authorities.
- 5. For any kind of misbehavior by a student or group of students with staff or creating disturbances in classroom / college premises, strict disciplinary action will be taken. A student expelled on disciplinary grounds will not be readmitted to this college.

- 6. The use of mobile phones in college, hostel and hospital is strictly prohibited.
- 7. If any student found using liquor or narcotics on hospital duty, college or in institute premises, she will be suspended from the institute for a specific period or be expelled from the institution.
- 8. Possession of weapons, explosive and other objectionable material in institute will result in being expelled from the institution.
- 9. Breakage of the articles in the laboratory will be replaced by the student if it is due to her negligence.
- 10. Taking active part in politics will result in being expelled from the institution.
- 11. Student reporting for hospital duty or entering the institute premises in a scruffy appearance is liable for disciplinary action.
- 12. Ragging is a criminal offense and is strictly prohibited in the college / hostel premises. Any student/students involved in such activities will be immediately expelled from the institution. Both junior and senior students are required to maintain cordial relationship with each other and a disciplined atmosphere in the college campus.
- 13. Membership in the Student Nurses' Association is compulsory.
- 14. Students shall be answerable for bringing any friends/relatives etc. to the college during regular classes, functions etc. without the permission of the concerned authorities.

9.6 HOSTEL RULES

- 1. Students attendance will be taken regularly along with breakfast (7:00 am), dinner (8:00 pm) and before going to bed (10:00 pm) by the warden.
- 2. Students are not allowed to use any personal electrical appliances in the hostel.
- 3. Students are allowed to use office phone/hostel phone in case of emergency with the permission of the Class coordinator or Warden.
- 4. Students are not allowed to keep extra money or valuable items in the hostel. Management is not responsible for its loss.
- 5. Without prior information, the authorities have right to search hostel or students personal belongings at any time to maintain discipline and decorum.
- 6. Lights and fans are to be switched off, when not in use and all lights should be switched off by 11 pm.
- 7. No outside food/individual celebrations are permitted inside the hostel.
- 8. Wastage of food is not allowed in the hostel. Food should not be taken inside the living room.

- 9. Students are not allowed to carry personal utensils/ Hostel Mess utensils inside/ outside the hostel mess hall.
- 10. The students must keep their room and surroundings neat and clean.
- 11. Relatives or parent are not allowed to enter the living rooms of the hostel.
- 12. List of relatives or visitors with photographs (who will visit the student during the Training period) has to be submitted duly signed by the parent/guardian.
- 13. No Visitors are allowed to visit the students on college/week days until and unless there is a genuine emergency except on the days permitted for out-pass by the management, failing which leads to cancellation of out pass.
- 14. Students are allowed to go out of the campus only on permitted days.
- 15. Students are sent home, only with the parent/guardian (whose photograph is submitted with authorized visitor form) twice in a month after filling the out pass which is duly signed by the class coordinator and principal.
- 16. Night out-pass for students will be permitted on alternate Saturday from 5.00 pm till Sunday 4.00 pm, and out-pass days will be finalized by the authorities.
- 17. Extra leave will not be granted to any student until and unless there is a genuine emergency. The permission has to be obtained from class coordinator and principal.
- 18. Students are allowed to Watch TV daily for English news from 5:30 pm to 6:30pm and on Saturday from 8.00 pm- 10.30 pm and on Sunday from 7.00 am to 10.30am.
- 19. The study hours will be from 6:30 pm to 10:00 pm (with break of 30 min for dinner) every day.
- 20. Students should bring the following articles at the time of joining:
 - (i) Blanket/Quilt
 - (ii) Bed sheets
 - (iii) Pillow with pillow cover
 - (iv) Plastic bucket with mug
 - (v) Stationary items
 - (vi) Wrist watch with a second hand
 - (vii) Cream colour (for SVBCON, Silvassa) or gray colour (for GCON, Daman) full sleeves sweater.
 - (viii) Rubber slipper
 - (ix) Umbrella.
- 21. Any damage to the Hostel property will be compensated by the student herself.
- 22. In case of any in-disciplinary act/ragging by the student in the hostel/college, she may be asked to vacate the hostel immediately/suspended/dismissed from the college depending upon the nature of the incident.
- 23. The management has the right to revise rules and regulations from time to time
