NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution, read with Government of India, Ministry of Home Affair, Order No. 7/1/65 Ests (A) dated 16th February, 1965 and the Department of Personnel and Training O.M. No. AB-14017/61/2008-Estt (RR) dated 24th March 2009 and in supersession of the earlier recruitment rules the Administrator of Daman and Diu is pleased to make the following Rules relating to recruitment to the General Central Services, Group 'B' Gazetted, post of Assistant Engineer / Assistant Surveyor of Works / Engineering Assistant in the Public Works Department, UT Administration of Daman & Diu namely:-

- 1. Short title, application and commencement: (1) These rules may be called the Administration of Daman & Diu Group 'B' Gazetted, post of Assistant Engineer / Assistant Surveyor of Works / Engineering Assistant post of Recruitment Rules 2011. (2) These rules shall apply to the posts specified in column 1 of the Schedule to these rules (hereinafter called the said schedule) and shall come into force from the date of publication in the Official Gazzette.
- 2. Number of post, Classification and Scales of Pay: The number of posts, classification of the said posts and the scales of pay attached thereto shall be as specified in column 2 to 4 of the Schedule to these rules: Provided that the Administrator of Daman & Diu may vary the number of posts in column 2 of the said Schedule from time to time subject to exigencies of work.
- 3. Method of recruitment, age limit and other qualification:
 The method of recruitment to the said posts, age limit, qualifications and other matters connected therewith shall be as specified in columns 5 to 13 of the said schedule.
- 4. <u>Disqualification</u>: No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service: Provided that the Administrator of Daman & Diu may, satisfied that such marriage is permissible under the

personal law applicable to such person and the other party to the marriage and that there are other grounds for so, doing, exempt any person from the operation of this rule.

- 5. Power to Relax: Where the Administrator of Daman and Diu is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training, New Delhi and Union Public Service Commission relax any of the Provisions of these rules with respect to any class or category of persons.
- 6. Saving: Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by Central Government from time to in this regard.
