In pursuance to the letter of the Hon'ble High Court, Bombay referred in the preamble 2 above, the Administrator of Daman & Diu and Dadra & Nagar Haveli is pleased to modify the order quoted at preamble 1) above, as under with immediate effect.

- 1) The deputation of Shri Rameshwar Vishwanathrao Jatale, Judge, City Civil Court and Additional Sessions Judge, Mumbai is hereby cancelled in respect of the cases arising from Union Territory of Daman.
- 2) Shri Rameshwar Vishwanathrao Jatale, Judge, City Civil Court and Additional Sessions Judge, Mumbai is hereby deputed to Diu for two days of **first week** of every month as per his convenience, till further orders, for trial of cases arising from the Union Territory of Diu.
- 3) For rest of days of the month, the charge of the Principal District and Sessions Judge, Diu shall be with Principal District and Sessions Judge, UT of Dadra & Nagar Haveli at Silvassa, **only for urgent matters**.
- 4) The charge in respect of cases arising from the Union Territory of Daman shall be with the Principal District and Session Judge, Union Territory of Dadra & Nagar Haveli at Silvassa, till further orders.
