NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution, read with the Department of Personnel and Training O.M. No. AB-14017/61/2008-Estt (RR) dated 24th March 2009 and in suppression of the earlier recruitment rules the Administrator of Daman and Diu is pleased to make the following Rules relating to recruitment to the General Central Services, Group 'B' (Non Gazetted, Non Ministerial), post of **Draughtsman Grade-II** in the Public Works Department, Administration of Daman & Diu namely:-

1. Short title, application and commencement :

- (i) These rules may be called The Administration of Daman & Diu, Public Work Department, Group 'B' (Non Gazetted, Non Ministerial), Recruitment Rules, 2011.
- (ii) These rules will come into effect from the date of publication of this notification in Official Gazette and will relate to appointment to various posts made on or after this date.
- (iii) These rules shall apply to the post specified in column 1 of the schedule to these Rules (hereinafter called as the said Schedule).

2. Number of post, Classification and Scales of Pay :

The number of posts, its classification and the scales of pay attached thereto shall be specified in column 2 to 4 of the Schedule annexed to the rules.

3. Method of recruitment, age limit and other qualification :

The method of recruitment, age limit, qualifications and other matters related to the said post shall be as specified in columns 5 to 13 of the said schedule.

4. Disqualification :

No person (a) who has entered into or contracted a marriage with a person having a spouse living or (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post :

Provided, that the Administrator of Daman & Diu may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.


5. Power to Relax :

Where the Administrator of Daman and Diu is of the opinion that, it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing, relax any of the Provisions of these rules with respect to any class or category of persons.

6. Saving :

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Other Backward Class, Ex-serviceman and other special categories of persons in accordance with the orders issued by Central Government from time to time in this regard.
