

U.T. ADMINISTRATION OF DAMAN & DIU
ACHIEVEMENTS & ACTIVITIES UNDER MAJOR
DEVELOPMENTAL SCHEMES

(For the month of June 2014)

The Union Territory Administration is committed towards providing an inclusive development to the population residing in the territory. A number of schemes for creation and upgradation of physical infrastructure and towards improving the socio-economic status of the citizens are being implemented by the U.T. Administration. The progress in this regard during the month of June, 2014 is highlighted below.

A. Progress under Infrastructural Developmental Works :

(i) New Major Works started during the month of June, 2014:

- Laying of Foundation Stone for Construction of 220/66 KV, 260 MVA Power Sub Station at Ringanwada, Nani Daman on 25th June, 2014 at a cost of Rs.38.80 Crore.
- Laying of Foundation Stone for Construction of 1 MW On-Grid Solar Power PV Plant at Magarwada, Moti Daman on 25th June, 2014 at a cost of Rs.8.50 Crore.
- Strengthening and Upgradation of asphalt road with hume pipe gutter from Vitthalnath Temple to Sweeper Quarter's under DMC, Daman at a cost of Rs. 55.24 lakh.
- Strengthening and Upgradation of asphalt road with Paver block footpath both side of the road at internal road in Manguerial in DMC area, Daman at a cost of Rs. 13.95 lakh.
- Providing and fixing paver block footpath from Charles Machado house to Chithiyawad, Moti Daman in DMC area, Daman at a cost of Rs. 11.86 lakh.

(ii) Major Works completed during the month of June, 2014:

- Inauguration of Jetty for Coastal Police at Daman on 13th June, 2014. The work has been completed at a cost of Rs. 2.98 Crore.

- Inauguration of Tennis, Basket-ball and Squash courts in Fort Area, Moti Daman on 13th June, 2014. The work was completed at a cost of Rs.51.00 lakh.
- Improvement, widening, raising and Beautification of Major District Road starting from Bhim Talav to Excise check post at Zari via Thanapardi has been completed at a cost of Rs. 6.75 Crore (3.03 Kms).
- Construction of Compound Wall around Raw Water Reservoir at Dunetha pond, Daman, has been completed at a cost of Rs. 96.25 lakh.
- Construction of Tourist Assistance Booth at Jampore Beach has been completed at a cost of Rs. 43.00 lakh.
- Construction of Coastal Police Station at Vanakbara, Diu has been completed at a cost of Rs. 42.63 lakh.
- Construction of 2 Nos. of additional 'A' type quarter for general pool on first floor of existing quarter near Treatment Plant at Ghoghla, Diu has been completed at a cost of Rs. 14.70 lakh.
- Providing and fixing paver block behind Yogeshwar Mandir, Moti Daman has been completed under DMC, Daman at a cost of Rs. 14.28 lakh.

B. Progress under Individual beneficiaries Oriented Schemes during the month of June, 2014 :

A number of schemes for the benefit of individuals are being implemented by the Administration, in which assistance in cash/kind is being provided by way of scholarship, pension, subsidy, loan, advances etc. The progress in this regard in various sectors during the month of June, 2014 is as follows:

➤ **Crop Husbandry**

- 4300 Kgs. of Paddy seed of Grade-4 variety has been supplied to District Panchayat for distribution among farmers.
- Tractors facility has been provided to 41 farmers on subsidy for Agriculture operations.

➤ **Education**

- Text Books have been distributed to 15801 students under Sarva Shiksha Abhiyan Mission.

- Provided nutritious food to about 8840 students (Std. I to VIII) under Mid-Day Meal scheme.
- Text Books have been distributed to 1002 Nos. of SC students and 3932 Nos. of ST students of Std. I to XII.
- Phase II of Workshop on Project 'A' of Sarvottam by CII-IQ, Bangalore was organized at Daman from 19th to 20th June, 2014. The Head Masters of various schools in the UTs of Daman & Diu and Dadra & Nagar Haveli attended the workshop and finalized the Vision and Mission statement of Sarvottam Project.

➤ **Health**

- Financial assistance released for a total of Rs.2.00 lakh to 40 Mothers under Matru Samrudhi Yojana (MSY) scheme @ Rs.5000/- to each beneficiary.
- LIC Jeevan Kishor (One time deposit) policy of Rs.41,800/- has been made in the name of 71 girl child under Dikri Development Scheme (DDS).

➤ **Agriculture**

- 1884 Nos. of Coconut Plants has been distributed to the 471 Nos. of SC/ST/Small and Marginalized (SM) farmers on 100% subsidy.
- Seeds minikit on 50% subsidy has been distributed to the 136 Nos. of SC/ST/SM farmers.
- Sprayer Pumps (2 beneficiaries) & Storage bin set (110 beneficiaries) has been distributed to SC/ST/SM farmers on 50% subsidy.
- Paddy Seed has been distributed to 366 Nos. of SC/ST/SM farmers on 50% subsidy.
- Tools / Implements set has been distributed to 14 Nos. of SC/ST/SM farmers on 50% subsidy.
- Submersible pump sets and other agriculture machinery has been provided to 5 Nos. of SC/ST/SM farmers on 50% subsidy.
- Tractors facility has been provided to 20 farmers on subsidy for Agriculture operations.

➤ **ICDS**

- Provided nutritious food to 7672 Children (06 months to 06 years).
- Provided Food grain to 1900 pregnant women & lactating / nursing Mothers.
- Provided nutritious food to 2016 Adolescent Girls – School Going.
- Provided nutritious food to 309 Adolescent Girls – Out of School.

➤ **Technical Education**

Stipend of Rs. 2.19 lakh (Rs. 1000/ per month per training) has been paid to 73 numbers of trainees under TSP for 3 months training from 1/03/2014 to 31/05/2014.

C. Organisation of important Events during the month of June, 2014:

- Training Programme was organized on 16th June, 2014 in which all the Registrars of Daman district were trained on Civil Registration System (CRS) application software.
- Statistical day was celebrated on 29th June, 2014. The communities were sensitized on the issue of maintenance of service sector statistics through banners.
- Inaugural function of Celebration of 'Anti Malaria month' from 1st June, 2014 to 30th June, 2014 was organised.
- Summer classes were organized for children of the age group of 6 to 15 years at Bal Bhavan, Daman. More than 50 students were trained/educated in activities such as drawing, dance (western and classical), music, craft etc.
- Daman District Inter School Football Tournament was organized from 25th to 28th June, 2014 for boys of under 17 years.
- Sports training Calendar for District Level Inter School Sports meets and UT Level Sports meet for the year 2014-15 has been finalized in the consultation meeting with Head Masters, Taluka Level Sports Officer, Asstt. Physical Education Officer and Physical Education Teachers.

D. Initiatives towards administrative reforms and e-Governance, if any.

Phase III of Samay Sudhini Seva i.e. Time bound services was launched on 13th June, 2014 at Conference Hall, Secretariat, Moti Daman in which 73 services of 18 departments were added under Samay Sudhini Seva.

Now, total 125 services of 22 departments of UT of Daman & Diu are providing time bound services to the people of UT of Daman & Diu.

E. Important Circular/Instruction issued to subordinate offices.

In the interest of providing a citizen centric/ friendly administration, the UT Administrations of Daman & Diu and Dadra & Nagar Haveli has issued the Order No.6/98/99-PER/2013-14/325 dated 13/05/2014 in which all the Departments of the Administration were directed to not take, any affidavit as a part of its service delivery process, except where required under a statute. Instead, a self-certified document with the same content as in the affidavit shall be taken.
