

U.T. ADMINISTRATION OF DAMAN & DIU
ACHIEVEMENTS & ACTIVITIES UNDER MAJOR
DEVELOPMENTAL SCHEMES

(For the month of May 2014)

The Union Territory Administration is committed towards providing an inclusive development to the population residing in the territory. A number of schemes for creation and upgradation of physical infrastructure and towards improving the socio-economic status of the citizens are being implemented by the U.T. Administration. The progress in this regard during the month of May, 2014 is highlighted below.

A. Progress under Infrastructural Developmental Works :

(i) Major Works completed during the month of May, 2014:

- Construction of Jetty for costal police at Daman has been completed at the cost of Rs. 2.98 Crore.
- Construction of Check dam on Kalai River at Kalu Khadi, Bamanpuja, Moti Daman has been completed at the cost of Rs. 99.92 lakh.
- Renovation and improvement of 8 numbers of "B" type quarters of Electricity department at Dabhel, Daman has been completed at the cost of Rs. 50.27 lakh.

B. Progress under Individual beneficiaries Oriented Schemes during the month of May, 2014 :

A number of schemes for the benefit of individuals are being implemented by the Administration, in which assistance in cash/kind is being provided by way of scholarship, pension, subsidy, loan, advances etc. The progress in this regard in various sectors during the month of May, 2014 is as follows:

➤ **Crop Husbandry**

- Supply of Paddy, Pulses, tools/Implements, Sprayer Pumps, Storage bin set and Agriculture machinery (50 % Subsidy) to 69 farmers.
- Tractors facility has been provided to 5 farmers on subsidy for Agriculture operations.

➤ **Animal Husbandry**

- Provided 200/- grown and vaccinated poultry bird at nominal cash rate of Rs.100/- kg base to 200 beneficiaries under Poultry Demonstration Farm Scheme.

➤ **Health**

- Financial assistance released of total Rs.25000/- to 5 Mothers under Matru Samrudhi Yojana (MSY) scheme @ Rs.5000/- to each beneficiary.

➤ **ICDS**

- Provided nutritious food to 4660 Children (06 months to 06 years).
- Provided Food grain to 1974 pregnant women & lactating / nursing Mothers.
- Provided nutritious food to 1270 Adolescent Girls – School Going.
- Provided nutritious food to 124 Adolescent Girls – Out of School.

C. Organisation of important Events during the month of May, 2014:

- A Summer Camp was organized by Bal Bhavan, Daman for children of the age group of 6 to 15 years from 1st May, 2014 to 15th May, 2014. About 200 children were trained/educated in activities such as art & craft, dance (western, classical), music, drama, yoga etc.
- The chess team of Bal Bhavan, Daman had participated in International Chess Championship affiliated by India Chess Association and World Chess Association at Sangli, Maharashtra and performed very well.
- Daman Open Badminton Tournament -2014 was organized from 28th May, 2014 to 31st May, 2014.

D. Recruitment (Appointment / Promotion) made during the month.

- 2 posts of Principal/ ADE and 03 posts of High School Head Master have been filled up by promotion in Education Department.
- 2 posts of Computer Compiler/Checker have been filled up in Department of Medical & Health Services.

E. Initiatives towards administrative reforms and e-Governance, if any.

- Urban Land records computerization and its digitization was completed and kept on the official website of UT Administration of Daman & Diu at www.daman.nic.in for verification of public/citizens. It is named as “AVANIKA URBAN” and part of the web portal “AVANIKA”.
- Union Territory Wide Area Network is the flagship Core IT infrastructure project of UT Administration of Daman & Diu. It has been implemented as a joint project of UTs of Daman & Diu and Dadra & Nagar Haveli. The Phase I of UTWAN project is completed. In **Phase I**, 61 offices of UT of Daman & Diu are connected. **Phase II** of the project is under implementation. 72 more offices will be connected under **Phase II**. In last **Phase III**, all the offices of UT Administration of Daman & Diu situated at Daman & Diu will be connected.
- Under National Land Records Modernization Programme, digitization and verification of rural land records data of Daman district is completed. The mutation of land records is also being done using “AVANIKA RURAL” software. The land record data is also available on the official website of UT Administration of Daman & Diu at www.daman.nic.in and “AVANIKA” portal.
- In e-PRI (Panchayati Raj Institutions) project, out of total 10 modules, **three modules** i.e. Panchayat portal, Area profiler and Local Government Directory are implemented. Three more modules i.e. Priya Soft, Plan Plus and Action Soft are under process of implementation.

F. Law and Order.

- On 16th May, 2014, results of the General Elections to Lok Sabha, 2014, were declared and BJP candidate Shri Lalubhai Patel won the Parliamentary seat of Daman & Diu, for which rally along with victory procession was taken out in entire Daman District. Police arrangements were made and the victory procession passed off peacefully.

G. Other Important Activity (in brief).

- In April 2013, the UT Administration had allotted all Govt. Schools among senior officers for detailed inspection of each school to identify the infrastructure gaps and other requirements.

All the officers had submitted their gap assessment report to the Administration. Accordingly, PWD and Director (Education) were directed to ensure that the identified gaps should be bridged on priority.

All the Govt. Schools have again been distributed among senior officers for submission of their report about status of bridging of the identified gaps. The report from all the officers has been received and analysis of the report is going on.

- The Biblos Market was inspected and found in a ruinous condition. Therefore, SVNIT, Surat was engaged to conduct condition assessment and health monitoring of the building in a week for further necessary action.
