**Terms of reference:**



- (ii) The Board will integrate the Draft Development Plan / Sectoral Plan submitted by the District Planning Committee in overall Plan of the UT.





The term of above Committee/Groups shall be a period of two years or till it is re-constituted. The Groups shall meet at least once in two months. The




Committee/ Groups shall evolve its own procedure of work and the record shall be maintained by the Member Secretary.
