# INSPECTION PROCEDURE AND CHECKLIST FOR OBTAINING CONSTRUCTION PERMISSION

The applicant submits the file for obtaining Construction permission in PDA in the prescribed Performa. After receiving the proposal, the inspection of the site is carried out within a week period by the concerned dealing hand and submits the same to member Secretary (PDA). The applicant is also informed about the inspection. The following documents are required for inspection:

- 1. The copy of Building Plan.
- 2. Location Plan/Index plan.
- 3. Copy of approved plan (if proposal is for revised approval)
- 4. Certified Site plan issued by the City Survey Office.
- 5. Ownership document
- 6. NOC of the Coast Guard Authority for height restriction
- 7. Provisional NOC of Fire Department.

# Check List of Documents to be submitted while making application for grant of new construction permission:-

- 1. Application in the form Annexure-II along with the form Annexure II to V
- 2. Copy of N.A. Order.
- 3. I and XIV nakal (Latest original plus one true copy)
- 4. If land is part of private Industrial Estate true copy of approved layout plan or a signed statement on company's letterhead that it is not applicable.
- 5. If part of private Industrial Estate, a certificate of completion of Development work as per approved layout plan or signed statement on company's letter head that it is not applicable.
- 6. Copy of the amalgamation order, if relevant or signed statement on company's letter head that it is not applicable and that N.A is for entire survey number.
- 7. Original certified Map of Survey/Plot no. issued by City Survey office, Daman.
