Sr. No	Name of the Document

- 1 Bill/Invoice of Weights, Measures
- (In case of new verification)
- 2 Last year Verification Certificate

TIMELINE

05 Days from the date of verification (In office)

07 Days from the date of verification (Outside office)

FEES

- Fees payable for verification and stamping at office as specified in Schedule IX
- For verification and stamping at any premises other than the office, an additional fee shall be charged at half the rate specified in the Schedule IX (See rule 17(2))
- No additional fee shall be charged for verification and stamping for
 - Fuel Dispensers, LPG Dispenser, CNG Dispensers, Weighbridges, Platform machines, Crane scales, Automatic Gravimetric Filling Instruments, Discontinuous Totalizing Automatic Instruments and such other weight or measure which cannot and should not be moved from its location.
 - Weight or measures in the premises of manufacturer or dealer of such weights & measures.
