ORDER

Sub :- Cancellation of Allotment order for Maintenance of Cricket Ground
situated at Govt. College, Daman.

Ref :- Our Order No. DMN/SPORTS/CRICKET/2011-12/276. dtd:- 27.12.2011

Whereas the Sports Department Daman has allotted Cricket Ground situated at Govt. College, Daman for maintenance and for conducting League Cricket Tournaments for the period of 3 years w.e.f. 1st January 2011 to 31st December 2014 with the following conditions:-


1. That the Association should maintain the pitches and surrounding areas of the ground and if any damage is caused, it should be repaired by the Association from its own funds. The cricket ground shall be in perfect playing condition.
2. That whenever the Cricket ground is required by UT. Administration, Daman, it should be spared for which the Sports Department, Daman should inform in advance so that the Cricket matches fixed can be adjusted.
3. Use of the Cricket for any other purpose except Sports shall be restricted and will be with the permission of the Secretary (Sports), U.T. of Daman & Diu.
4. That this permission can be withdraw by UT. Administration at any time without giving any notice to the Daman District Cricket Association.

The U.T. Administration of Daman & Diu has decided to develop the said ground for better facilities. The Department has to handover the said ground to the PWD, Daman for further process.

In view of above the Department has canceled the allotment order as mention above with immediate effect.
