
NOTIFICATION

No. 7-7/EC/DD/2017: In exercise of the powers conferred on it under Rule 25 of the Daman and Diu Panchayats (Election Procedure) Rules, 2014 and in partial modification of its Notification No. 7-7/EC/DD/2017 dated 16.11.2017, the Election Commission for the Union Territory of Daman and Diu, appointed under Section 185 of the Andaman and Nicobar Islands (Panchayats) Regulation, 1994, hereby appoints the following officers as Assistant Returning Officers for the wards shown against their names / designations.

S. No.	Name and designation of the Assistant Returning Officer	Name(s) of wards of Gram Panchayat
1.	Shri M.B. Kamalia, Vice-Principal, TTI, Diu	All wards of Gram Panchayat Zolawadi, Diu
2.	Shri C.D. Vaja, Mamlatdar, Diu	All wards of Gram Panchayat Bucharwada, Diu

As provided under sub rule (2) of Rule 25 of the said rule, every Assistant Returning Officer shall subject to the control of the Returning Officer, be competent to perform all or any of the functions of the Returning Officer provided that no Assistant Returning Officer shall perform any of the functions of the Returning Officer which relate to the scrutiny of nominations unless the Returning Officer is unavoidably prevented from performing the said function.
