### **CIRCULAR**

The New Year's celebration in Daman attracts large number of Tourists. In order to maintain Law & Order and to facilitate the celebrations, the following instructions are issued for the compliance of various department/Office.

1. The Sub Divisional Police Officer, Daman shall give special attention to traffic regulation/control, and Law and Order.
2. Proper security arrangements shall be made by Sub Divisional Police Officer in the entire District and especially at the thickly congregated/Vulnerable Areas like Devka, Jampore and Tin Batti etc.
3. The Executive Magistrates shall patrol the Urban & Rural Area and assist the police in maintaining Law & Order.
4. The Sub Divisional Police shall open an assistance cell for the benefit of the Tourists.
5. The Excise staff shall patrol the Areas and check the Bars & Restaurants land scale of liquor outside premises.
6. The Joint Director-cum-Joint Secretary, D&D /RTO/Inspector shall also regulate the traffic and shall book the cases against the offenders who violate Motor Transport Act Rules.
7. Director of Fire Service shall place fire tender at the police station to meet any emergency.
8. The Director of Medical & Health Service, Daman will keep Ambulance and the other Medical Services available round the clock to deal with any emergency, both at PHC, Moti Daman and at Govt. Hospital, Marwad.
9. The Sub Divisional Magistrate, Daman shall Co-ordinate that activities of police, Executive Magistrates, Medical Services etc. and Control Room from 06:00 pm. of 31<sup>st</sup> December 2019 to 06:00 am. of 1<sup>st</sup> January 2020.
