## CORRIGENDUM

Reference : Tender Notice No. ADTr/396/Vol-II/05/PART-I/641 dated 19/01/2012 for supply of 'High Security Registration Plates' (HSRP) in the Union Territories of Daman & Diu and Dadra & Nagar Haveli.

The following amendments are made in the Bid documents (Request for Qualification cum Request for Proposal Document ("RFQ cum RFP") published vide Tender Notice No. ADTr/396/Vol-II/05/PART-I/641 dated 19/01/2012 for supply of 'High Security Registration Plates' (HSRP) in the Union Territories of Daman & Diu and Dadra & Nagar Haveli.

**(1) Clause 2.2.1. B, d may be read as below :**

The successful bidder will have to establish a manufacturing unit for High Security Registration Plates in India; provided that the production facility / Embossing Station should be established at the offices of all the registering authorities.

**(2) The clause 2.2.1 B, f may be read as below :**

The Bidder or any of the Eligible Members of Consortium shall have obtained "Type Approval Certificate (TAC)" on or before submission of bid and must be valid on the date of opening of bid from the designated Test Agencies in India for High Security Registration Plates as per specification laid down, in the Gazettee Notification cited above.




**(3) Clause 2.3.16 may be read as below :**

The Bidder shall deposit a Bid security of ₹5 Lacks (Rupees five lacks only) in accordance with the provisions of this RFQ cum RFP. The Bidder has the option to provide the Bid Security either as a Demand Draft or in the form of a Bank Guarantee acceptable to the Authority, as per format at Appendix-4.

All other clauses remain unchanged; provided that the clauses in which the above condition / requirement reflecting shall also be modified to the extent stated above accordingly.
