The condition for supply are as under :-

1. The Float/Tableau shall express / exhibit the given theme by using sculptures, painting, persons, live performance and mounted on suitable vehicle.
2. The Tenderer should quote their rates on their own letter pad OR on plain paper with their rubber stamp. Rate should be quoted against work, commensurate with the proposed exhibit and should be inclusive of all taxes.
3. The Tenderer should pay the EMD as specified herein above in the form of Deposit at call/Demand draft. The EMD of the successful Tenderer will be converted/treated as "Security Deposit" and retained with department till successful completion of supply.
4. The successful tenders has to furnish Security Deposit of an amount equal to 5% of cost put to tender.
5. The work should be completed by 25/01/2017. The work should conform to the given specifications & should be displayed on 26/01/2017 at the Republic Day Function in Daman.
6. The payment will be made after completion of work and at the satisfaction of this Department.
7. Income Tax will be deducted as per the-I.T. Rules. Labour cess will also be deducted as per rules.
8. The sealed tender should reach this office up to 4.00 P.M on 19/01/2017 in sealed envelope super scribed as "for Making of Float/Tableau" and it will be opened on the same day, if possible, in presence of bidders or their representatives, if present.
9. The rates should be valid up to six months from the date of Tender Notice.
