

- 6 The supplies which found to be defective or in damage condition or otherwise not conforming to the given specifications will be rejected. The supplier has to replace the same within specified period of time.
- 7 The quantity to be supplied will be subject to replacement without prior notice.
- 8 Interested parties should submit the copy of GST Registration Certificate, PAN and Seeds sales license.
- 9 The Payment will be made through direct bank accounts by RTGS only after successful completion of supply to the satisfaction Chief Executive Officer, District Panchayat, Daman
- 10 The sealed tender should reach this office up to 12.00 a.m. on 25/05/2018 in the sealed envelope Superscripted as "**Tender for supply of Paddy Seeds**" the Tender will be opened on the same day at 4.00 p.m. in the presence of parties or their authorized representatives, if possible.
