ADDENDUM - 1

The Following additional condition for Five years Free maintenance Guarantee Bond is added in NIT in the Sr. No.2 Bid-(E-501) (ID-2018_DAMAN_32_1) tender documents:-

ADDITIONAL CONDITION FOR FIVE YEARS FREE MAINTENANCE GURANTEE BOND

1. The Contractor shall have to give for "Five years period" free maintenance guarantee bond from the date of completion. During this period contractor will be liable for repair of damaged portion of the C.C. surface of road and any structures i.e. cross drainage, masonry gutter etc. at his risk and cost and as directed by Engineer in charge. If the Roughness Index of C. C. surface during the maintenance period of for "Five years period" is poorer than 4000 mm/km then agency would be liable for providing entire renewal coat with C.C. as per the direction and satisfaction of Engineer in charge.
2. Total 5% of the tender Value shall be withheld as S.D. which will be released to the agency after the expiry of guarantee period (i.e. "Five monsoon period"). During the above period, the contractor will have to provide the C.C. surfacing as per the direction and satisfaction of engineer in charge if "C.C." surface It is noticed as damaged or otherwise total 5% of the tender Value kept as SD will be forfeited.
3. The Performance Guarantee shall be refunded to the contractor after completion of one monsoon period from recording of the completion certificate of the said work.
4. For earth work, water bound C.C. / Asphalt items the compactions shall be done with vibratory roller only. The vibratory roller shall be of standard make and suitable to impart desired degree of compaction. The compaction with the help of static roller shall not be permitted and no claims what so ever shall be entertain on this account. Wherever use of the road roller is mentioned in specification / clause etc. In these documents, it shall be treated as use of vibratory roller. Minimum two vibratory rollers will be deployed by the agency for any of the C. C. / Asphalt works.
5. 10% of the amount eligible for the Payment C. C. / Asphalt items shall be withheld till the miscellaneous items like earth work in embankment / cutting for side shoulders, side gutters, kilometer/hectometer / indicator / guard stone, sign boards etc. are completed in all respect by the contractor. If the items are the components of the tender agreement. After completion of all the miscellaneous items the above said 10% with held amount shall be releases.
6. The Grit shall be spread at the rate and grade specified by means of mechanical sprayer with specified grade, lime and cross-section.
