### **GENERAL TERMS AND CONDITION:**

1. The rate(s) quoted should be strictly for transportation from the loading point at kirkee (pune) to unloading point at Daman as directed by the department.
2. The rates should be quoted inclusive of all taxes. Any other taxes, challan & penalties etc. payable will be the responsibility of the tenderer and will be deducted from the bill by the department.
3. G.S.T as applicable has to be paid by the tenderer.
4. All other Taxes/duties/royalties charges payable on the transport etc. within and/or outside the State, the supplier shall be responsible for the same.
5. No extra charge for handling and insurance etc. will be paid on the rates quoted.
6. **The rates should be quoted only for the transportation of War tank weighing from Kirkee (Pune) to Daman confirming to the service and standard(s) requirements for the said work.**
7. The tender must include two envelopes named as “Technical Bid” and “Financial Bid” and both the tenders should be sealed and submitted in an outer envelope super as “Lifting & Transportation of 02 Nos. of War Tank from Kirkee (Pune) to Daman.”
8. Where specifications/type of vehicle are not specified by this office the rates should be quoted only for the Vehicle capable for “Lifting & Transportation of 02 Nos. of War Tank (40 tons each) from Kirkee (Pune) to Daman.” showing the specification intender.

9. The decision of the Tender Inviting Officer for acceptance or rejection of any item mention including the decision for equivalent specification, vehicle and service etc. of agency/transporter shall be final.
10. The tenderer should enclose E.M.D. of **Rs. 10,000/-** with tender as Earnest Money Deposit by drawing a Demand Draft of any scheduled Bank at Daman in favour of the Officer Inviting Tenders. Tenders received without Earnest Money will be summarily rejected.
11. The amount of Earnest Money paid by the Tenderer (s) in form of EMD and whose tenders are not accepted, the Cheque or Demand Draft will be refunded to them by the Tender Inviting Officer.
12. Only on satisfactory completion of the transportation, the amount of Security Deposit or Earnest Money deposit will be refunded after expiry of guarantee period, if any or any such date/ period as may be mutually agreed upon.
13. The Head of Office will consider extension of item for remitting the Security Deposit as demanded. However, in case of denial to consider such extension the supplier is bound to abide by the limit given and liable to make good any loss to the Government on account of his failure to abide by the limit.
14. The “Lifting & Transportation of 02 Nos. of War Tank from Kirkee (Pune) to Daman.” as per tender document if found of bad condition / standard or of different specifications after then that ordered/ specified and / or different vehicle will not be accepted. The delivery will have to be done at his own cost and risk. However, if no communication the Tender inviting officer will not be responsible for any damage, loss etc. if any.
15. In case of failure to replace the accepted and rejected work from tenderer made, as mentioned in the conditions, the loss undergone by the Govt. will be recovered from the tenderer from security deposit/ earnest money.

16. In case of failure to do the “Lifting & Transportation of 02 Nos. of War Tank from Kirkee (Pune) to Daman.” ordered for as per conditions and within the stipulated time limit, the same service will be obtained if required from the tenderer who offered next higher rates or from any other sources, as may be decided by the Tender Inviting Officer and the loss to the Govt. on account of such expense be recovered from the former supplier from security deposit/ earnest money deposit or bill (s) payable.
17. The tenderer shall have no any right to dispute with such procedure. If any time after the order “Lifting & Transportation of 02 Nos. of War Tank from Kirkee (Pune) to Daman.” the tender Inviting Officer shall for any reason what so ever not required the whole or part of the service as per specification in the order the Tender Inviting Officer shall give notice in writing to the supplier who shall have no claim to any payment of compensation whatsoever on account of any profit or advantage which the supplier might have deprived from the transportation of goods/items in full quantity of articles not having been purchased not shall have any claim for compensation by reason of any alteration having been done in the original instructions which shall involve any curtailment of the supply original contemplated.
18. The Earnest Money/ Security Deposit(s) paid by the Tender earlier against any tender(s) or supply order(s) is/are not adjustable with EMD or Security Deposit required by these conditions.
19. All bills should be in DUPLICATE and should invariably be mention the number and date of supply order.
20. If possible the tenders will be opened in presence of Tenderer or their representative if any present in the office of the Tender Inviting Officer.
21. The right to accept or reject without assignment any reason any or all tenders in part or whole is reserved with the Tender Inviting Officer and his decision(s) on all matters relating to acceptance or rejection of the tenders as a whole or in part will be final and binding to all.

22. If the tenderer whose tender/quotation is accepted fails to execute the work order within stipulated time the EMD of such tender will stand forfeited to the Govt. and the for the supply shall stand terminated with no further liabilities on either party to the contract.
23. The tenderer shall submit the GST registration certificate of the firm, PAN card and three years IT return of the firm/proprietor.
24. Eligibility Criteria
- I The agency should have experience of working with any government organization. A proof in the form of work order must be attached along with the tender.
25. No Separate agreement will be required to be signed by the successful tenderer(s) for the work of the contract for Transportation. Rates tendered/offered in response to the concerned tender/quotation notice shall be considered as acceptance of all legal purpose.
