**TERMS & CONDITIONS:-**

1. The auction of Split type Air Conditioners /Xerox Machine shall be carried out under the supervision of the committee of the Dy. Director of Transport, Daman the Motor Vehicle Inspector, Daman & UDC ,on 01/06/2018 at 11:30 AM
2. The interested bidder shall have to deposit a token amount of Rs 500/- for Air Conditioners at the time of auction for taking part in it. The said amount shall be refunded back to the unsuccessful bidder after the auction. The successful bidder has to deposit 10% of the offered bid on the spot.
3. The bidder should offer bid for a minimum of Rs 500/- (Rupees five hundred only) above the upset price of all Air Conditioners.
4. An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
5. The upset price of Air Conditioners are Rs 9,600/-,Xerox Machine Rs.3000/-
6. The successful bidder shall have to lift the auctioned materials within three days from the date of finalization of the auction after which this office shall not be responsible for their safe custody.
7. The interested parties should inspect the Air Conditioners & Xerox Machine and satisfy themselves about their conditions etc during office hours Monday of Friday up to 17:00 hrs.
