**NOTIFICATION**

WHEREAS, in pursuance of the provisions of Article 243 K(1), Article 243 Z(A), of the Constitution of India, Section 99 of the Dadra and Nagar Haveli and Daman and Diu Panchayat Regulation, 2012 and section 5 of the Dadra and Nagar Haveli and Daman and Diu Municipal Council Regulation 2004, the Election Commission for Dadra and Nagar Haveli and Daman and Diu, has, vide its Notification No. 7-2/EC/DD/2020 (A) dated 15th October 2020, specified that the electors above the age of 80 years, electors with physical disability (who are unable to stand and walk without help of an attendant) and electors on election duty (including police personnel) who request for voting by postal ballot papers would be a class of persons to give vote by postal ballot in the General Elections/Bye Elections to Panchayats and Municipal Councils in Dadra and Nagar Haveli and Daman and Diu.

WHEREAS the UT Administration of Dadra and Nagar Haveli and Daman and Diu has brought to the notice of this Commission today, i.e. 16.10.2020, that the UT Administration has amended the Dadra and Nagar Haveli Municipal Council (Elections) Rules, 2005 vide Notification No. UD/DNH/SMC/Elections/Rules/2015/28 dated 21<sup>st</sup> January, 2016, and has also amended the Daman and Diu Municipalities (Elections) Rules, 1995 vide Notification No. UD/DMN/DMC/Election/Rules/66/2015/988 dated 23<sup>rd</sup> December, 2015 making thereby provision for casting of votes by electors on election duty through EVMs;

Now, therefore, the Election Commission, Dadra and Nagar Haveli and Daman and Diu partially modifies its Notification No. 7-2/EC/DD/2020 (A) dated 15th October, 2020, and clarifies that **“electors on election duty (including police personnel), would not be a class of persons to give vote by postal ballot in the General Elections/Bye Elections to Municipal Councils in Dadra and Nagar Haveli and Daman and Diu”**.
