Read: Business Reforms Action Plan, 2020 (Point Nos. 221, 225, 229) issued by the Department for Promotion of Industry and Internal Trade & Industry, Government of India, New Delhi.

ORDER

As a part of State Reform Action Plan 2020-21, the Department for Promotion of Industry and Internal Trade & Industry, Government of India, New Delhi has proposed to define the clear timelines mandate through the Public Service Delivery Guarantee Act (or equivalent) legislation for approval of complete application for various services under the Drugs & Cosmetics Act, 1940.

2. The "Samay Sudhini Seva" has already been implemented by the UT Administration of Dadra & Nagar Haveli and Daman & Diu, in order to ensure that the services are provided to the citizens in a prescribed timeline.
3. Therefore, the Drugs Control Department, Dadra & Nagar Haveli and Daman & Diu shall accord deemed approvals /clearance /recommendation (as the case may be), in case the concerned approving department/ authority does not provide clearances within their specified timelines as per following prescribed time lines under applicable Laws/ Regulations/ Rules in respect of the following Services: -


DRUGS CONTROL DEPARTMENT: -

Aforesaid Services are to be provided in prescribed time limit, failing which approval would be granted to the applicant and Responsibility of the Officer/Official shall be fixed for causing delay in providing services in time bound manner and necessary departmental proceeding may be initiated against the concern.

Further, if, any query/clarification related to application, the concern department will communicate the same to the applicant once within the period as prescribed above.
