



Dear Sri Rajiv Mehrishi,

You may recall that this Department has been encouraging voluntary Blood Donation Camps in offices under Central Ministries once every two months and impressing upon States to replicate the same as far as possible. Please refer to the tele-conversation held with you a few days ago in which you had sought an update on the voluntary blood donation efforts in 2015-16 in the State of Rajasthan. I have obtained requisite information from the Medical & Health Department and the up-to-date progress is as below:-

1. A total of 2855 voluntary blood donation camps were organized across the State in which, out of a total 4,25,267 blood units collected, 3,49,733 blood units were collected on voluntary basis.
2. On 25.9.2015 on the occasion of the birth anniversary of Pandit Deen Dayal Upadhyay, 96 voluntary blood camps were organized in which 10,000 units of blood were collected.
3. In 2016-17 the following organizations have committed to organize 10 or more voluntary blood donation camps:
  - i) HDFC Bank,
  - ii) Akhil Bhartiya Terapanth Yuvak Parishad,
  - iii) Jain Social Group
  - iv) Jain Social Group Topaz
  - v) Adarsh Charitable Trust,
  - vi) Lions Club
  - vii) Rotary Club
  - viii) Railway Employees Union,
  - ix) Khartargchh Jain Yuvak Parishad
  - x) Saint Nirankari Mandal

Overall, for 2016-17, it is proposed to take the services of 2200 voluntary organizations to organize over 3000 blood donation camps across the State.

In accordance with the norms prescribed in this regard, total quantum of voluntary blood donation to total blood collection has been above 85%.
