## CIRCULAR

In pursuance to the above mentioned Notification received from Office of Registrar General, India, New Delhi it is to inform that the Ministry has directed that for registration of death the Aadhaar number will be required for the purpose of establishing the identity of the deceased for the purpose of **Death registration**. w.e.f. 1<sup>st</sup> October, 2017 in the following manner:

- i) An Applicant applying for death certificate is required to provide Aadhaar Number or enrolment ID Number (EID) of the deceased and other details as sought in the application for death certificate for the purpose of establishing the identity of the deceased.
- ii) An Applicant who is not aware of the Aadhaar number or EID of the deceased will be required to provide a certificate that the deceased person does not possess Aadhaar number to the best of his/her knowledge and it should be duly informed and also prescribed that any false declaration given by the applicant in this regard will be treated as an offence as per the provisions of the Aadhaar Act, 2016 and also Registration of Births and Deaths Act, 1969.
- iii) Applicant's Aadhaar number shall be collected along with the Aadhaar number of the spouse or parents.

All the Registration Authorities are requested to take note of the same and ensure strict compliance with effect from the above mentioned date.
