



TERMS & CONDITIONS :-

1. The auction of **Scrap** unserviceable items shall be carried out under the supervision of the committee consisting of the Executive Engineer, PWD, Daman, the Assistant Engineer, PWD, SD-IV, Daman & Divisional Accountant, P.W.D., WD-I, Daman on **03/08/2019** at 11.00 AM.
2. The interested bidder shall have to deposit a token amount of ₹.500/- at the time of auction for taking part in it. The said amount shall be refunded back to the unsuccessful bidder after the auction. The successful bidder has to deposit 10% of the offered bid on the spot.
3. The bidder should offer bid for a minimum of ₹.500/- (Rupees Five Hundred only) and above the upset price of total nos. of all Air Conditioner.
4. An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
5. The upset price of Air Conditioner is ₹.10,000/- for unserviceable items.
6. The successful bidder shall have to lift the auctioned Air Conditioner within three days from the date of finalization of the auction and after payment of full amount after which this office shall not be responsible for their safe custody.
